Whitefield Town Meeting Minutes July 18, 2020

To: Robin Huntley, Resident of the Town of Whitefield, County of Lincoln, State of Maine.

GREETINGS:

In the name of the State of Maine, you are hereby required to notify the voters of Whitefield, Maine, qualified to vote on Town affairs, to meet at the Whitefield Central Fire Station in said Town on the Fourteenth day of July, 2020, at 7:45 AM, then and there to act upon Article 1 and by secret ballot on Article 2, the polling hours therefor to be from 8:00 AM in the morning until 8:00 PM in the evening:

Pursuant to Title 21-A, Section 759(7), absentee ballots will be processed at the polls at the following time of 8:00 PM.

And to notify and warn said voters to meet at the Whitefield Elementary School in said Town on the Eighteenth day of July, 2020 at 10:00 AM then and there to act on Articles 3 through 47 as set out below, to wit:

Interim Clerk Tina Laskey opened the meeting at 7:45 AM on Tuesday July 14, 2020 and called for nomination of a moderator.

On Saturday July 18, 2020 Select Board Chair Lester Sheaffer explained budgetary cuts that were made to the Warrant due to the Covid-19 pandemic.

Jeffrey Frankel explained meeting procedures.

There was a motion to allow Fire Chief Scott Higgins to speak at the meeting. Motion was seconded and passed.

Select Board Member Charlene Donahue delivered the Spirit of America Award speech honoring the Whitefield Volunteer Fire Department.

Article 1. To elect a moderator by written ballot to preside at said meeting.

• Jeffery Frankel was nominated Moderator. The nomination was seconded and he was elected by written ballot. Robin Huntley was appointed Warden.

Article 2. To elect by secret ballot municipal officers namely, two Select Board Members/Assessors/Overseers of the Poor for three-year terms; one RSU 12 School Board Member, for a one-year term; two openings on the Planning Board for two-year terms; and one opening for Road Commissioner for a three-year term.

 Select Board: William McKeen was elected with 408 votes, Charlene Donahue was elected with 421 votes. RSU 12: Suzanne Balbo was elected with 66 votes.
 Planning Board: Margaret Mason was elected with 494 votes. Road Commissioner: David Boynton was elected with 499 votes. **Article 3**. To see if the Town will fix dates when taxes shall be due and payable, and to see if the Town will fix an annual interest rate to be charged on unpaid taxes after said dates, and to allow the Tax Collector and Treasurer to accept the prepayment of taxes not yet committed pursuant to 36 M.R.S.A §506. 19/20 budget year interest rate 4%.

SELECT BOARD RECOMMENDS: Taxes due November 30, 2020 and April 30, 2021 and a 4% interest rate for unpaid taxes.

Article 3 was passed without discussion.

Glenn Angell moved to combine Articles 4 through 11. The after discussion the motion was seconded and carried. All eight articles were passed in one vote.

Article 4. To see if the Town will vote to appropriate from surplus funds to pay for tax abatements and any interest due thereon.

• Articles 4 through 11 were passed in one vote.

Article 5. To see if the Town will vote to authorize the Town Tax Collector to enter into a standard agreement with taxpayers establishing a "tax club" payment plan for property taxes, whereby:

- the taxpayer agrees to pay specified monthly payments to the Town based on his or her estimated and actual tax obligation for the current year property taxes;
- the Town agrees not to charge interest on timely payments made pursuant to the tax club agreement;
- the Town authorizes the Town Tax Collector to accept tax club payments for current taxes which may be due prior to the commitment of those taxes.
- the agreement is automatically terminated if a scheduled payment is late, and the taxpayer then becomes subject to the same due dates and interest dates and rates as other taxpayers who are not participating in a tax club.
- only taxpayers who do not have any outstanding tax obligations for prior tax years are eligible to participate in the tax club program.
- taxpayers wishing to participate in a tax club for a particular property tax year shall enter into an agreement with the town by a publicly advertised deadline determined by the Town Tax Collector.
- Articles 4 through 11 were passed in one vote.

Article 6. To see if the town will authorize the Treasurer to waive the foreclosure of a tax lien mortgage pursuant to 36 M.R.S.A §944 upon finding by the Select Board that ownership of the property subject to the lien would be contrary to the Town's best interest.

Articles 4 through 11 were passed in one vote.

Article 7. To see if the Town will vote to authorize the Select Board to enter into multi-year contracts to negotiate optimal value for the procurement of certain necessary services to the Town.

Articles 4 through 11 were passed in one vote.

Article 8. To see if the Town will vote to authorize the Select Board on behalf of the Town to sell and dispose of any real estate acquired by the Town for nonpayment of taxes thereon, for such terms as they deem advisable and execute quitclaim deeds for the same; with the exception that the Municipal Officers shall use the special sale process required by the new elderly tax law 36 M.R.S. § 943-C for a qualifying homestead property if they choose to sell it to anyone other than the former owner(s).

Articles 4 through 11 were passed in one vote.

Article 9. To see if the Town will vote to authorize the Select Board to accept gifts of money or personal property to the Town and to appropriate and expend such gifts for such public purposes as the Select Board deem to be in the best interest of the Town.

• Articles 4 through 11 were passed in one vote.

Article 10. To see if the Town will vote to authorize the Select Board to apply for and accept state and federal grants and grants from nonprofit organizations on behalf of the Town for municipal purposes including, when necessary, the authority to sign the grant contract and accept the conditions that accompany grant funds, and to appropriate and expend grant funds for the authorized purposes.

Articles 4 through 11 were passed in one vote.

Article 11. To see if the Town will authorize the Select Board to dispose of town owned property valued up to \$1,000. Property valued over \$1,000 will be sold through auction or sealed-bid process.

Articles 4 through 11 were passed in one vote.

Glenn Angell moved to adopt Articles 12 through 40 in one vote. After discussion the motion was seconded and carried. All twenty-eight articles were passed in one vote.
