Whitefield, Maine Annual Town Meeting March 18, 2006

The Whitefield Town Meeting was held at the Whitefield Townhouse March 18, 2006, to vote on Articles for the July 1, 2006, through June 30, 2007, fiscal year.

The meeting was called to order by Gwyn Dixon at 10:00 a.m. She read the preamble to the warrant and constable's return and acted upon Article 1.

Article 1. To choose a moderator to preside at said meeting.

Sandra Brown was elected moderator.

Mrs. Dixon administered the oath of office before the assembled voters. Ms. Brown then declared the polls open. Polls were open until 5:00 p.m. Following are the results of the secret ballot election:

Shall the Town of Whitefield appropriate \$3,161,817.36 for the total cost of funding public education from Kindergarten to Grade 12 as described in the Essential Programs and Services Funding Act and shall the municipality raise and assess \$1,002,440.00 as the municipality's contribution to the total cost of funding public education from Kindergarten to Grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes Title 20-A, section 15688, provided that any amounts raised and appropriated under Article 40 may be considered to have been raised and appropriated under this article to the extent necessary to conform the amounts raised and appropriated under this article to the State's Essential Programs and Services Model for the Town of Whitefield for FY 2007.

Explanation: The Town of Whitefield's contribution to the total cost of funding public education from Kindergarten to Grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality must raise in order to receive the full amount of state dollars.

Additional Local Funds Shall the Town of Whitefield raise and appropriate the sum of \$456,817.75, in additional local funds under the Maine Revised Statutes, Title 20-A, M.R.S.A. section 15690, which may exceed the State's Essential Programs and Services Funding model by as much as \$456,817.75.

Explanation: The additional local funds are those locally raised funds over and above the Town's local contribution to the total cost of funding public education from Kindergarten to Grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual debt service payment on non-state-funded school construction projects or the non-state-funded portion of a school construction project that will help achieve the municipality's budget for educational programs.

Shall the Town of Whitefield authorize the School Committee to expend \$3,852,221.00 for the fiscal year beginning July 1, 2006 and ending June 30, 2007 from the Town's contribution to the total cost of funding public education from Kindergarten to Grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.
