### Motor Vehicle Re-Registration Form

This form is to be used to re-register a motor vehicle, motorcycle, camper or trailer that is currently registered in your name in the Town of Whitefield. Please use a separate form for each vehicle to be re-registered. If your registration is currently under suspension, we cannot process your registration. If you are required to file SR-22, only excise will be collected. The remainder of the registration must be completed through the state.

What to do:

1. Call the Town Office at 207-549-5175 to get the amount of your registration.
2. Fill out the required information below.
3. Return the completed form either by mail to the address above or drop it in the mail slot at the same address. Please include:
  - ✓ A check or money order made out to the Town of Whitefield.
  - ✓ A photocopy of your current insurance card or ask your insurer to fax your card (one page only) to 207-549-3231. We cannot process your registration without proof of coverage.

Credit cards are accepted with a 2.5% third-party processing fee. Card numbers will be redacted after processing. If you do not wish to provide your card information, you may make your payment over the phone when your registration is being processed, please provide just your contact number.
